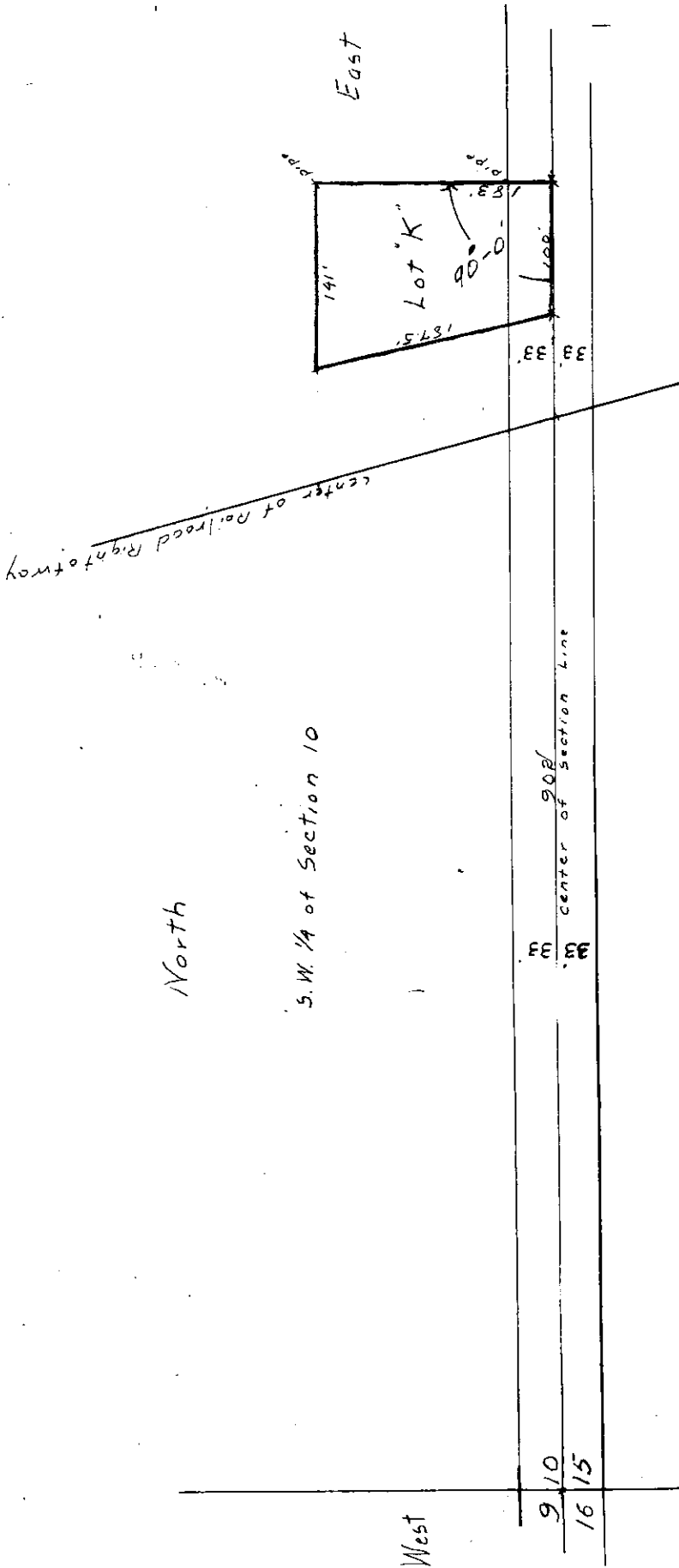

RESOLUTION

WHEREAS, there has been submitted to the Town Board of the Town of Monroe, Turner County, South Dakota, a plat of a parcel of land situated within the boundaries of the Town of Monroe, Turner County, South Dakota, to be known as Lot "K" being a part of S.W. 1/4 of Section 10, Township 100, Range 54, Turner County, South Dakota, and formerly described as follows:

Commencing at a point 902 feet East of the Southwest corner of Section 10, Township 100, Range 54 for a point of beginning, running thence East 100 feet, thence North 180 feet, thence West 141 feet, thence Southeasterly in a straight line to the point of beginning, being a part of the S.W. 1/4 of Section 10, Township 100, Range 54, Turner County, South Dakota, being in the Town of Monroe, Turner County, South Dakota.


WHEREAS, said plat has been duly examined by the Town Board of the Town of Monroe, Turner County, South Dakota, and

It appearing to the said Town Board that the system of streets and alleys set forth therein conforms to the system of streets and alleys of the existing plat of the Town of Monroe, South Dakota; that all taxes and special assessments, if any, upon said property have been fully paid, and that such plat and the survey thereof have been executed according to law,

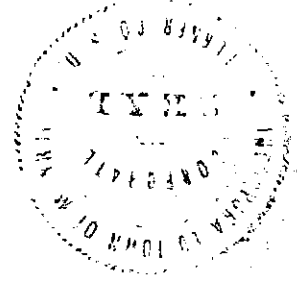
