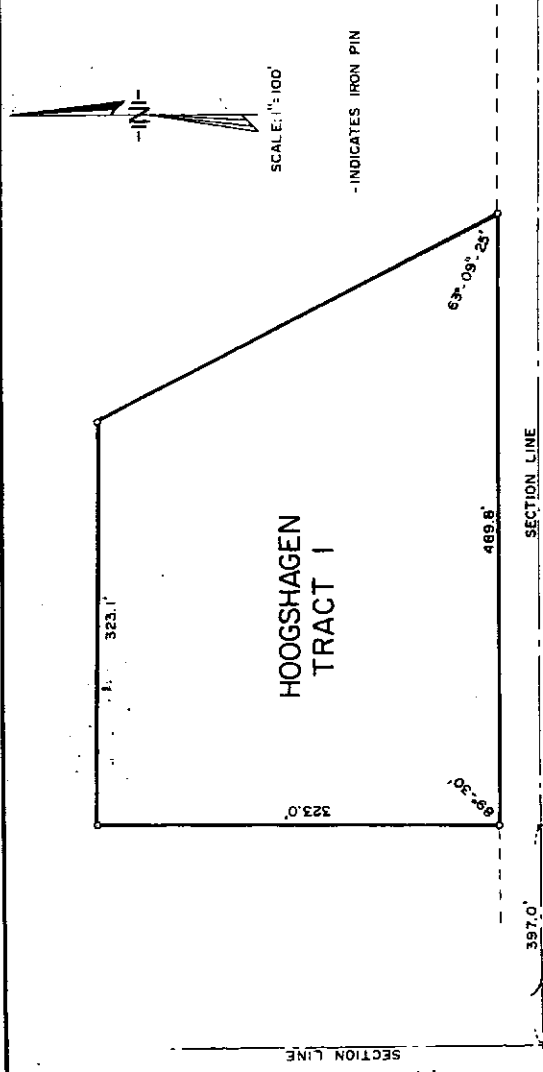

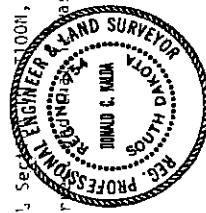


SURVEYOR'S CERTIFICATE

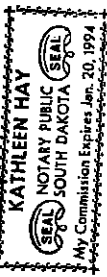

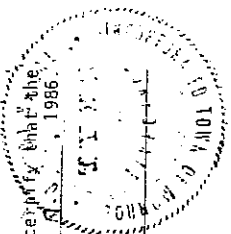

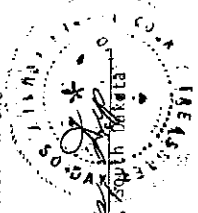
